#### Environmental Fate

There is evidence of rapid hydrolysis in soil. Rapidly degraded in soil;  $DT_{50}$  for microbial degradation 23-82 days, for field soil 6-40 days. Strongly adsorbed to soil and sediment organic matter,  $K_{oc}$  330,000. There is evidence of photodegradation in water. There is evidence of rapid biodegradation in soil and water. Negligible potential for leaching of lambda-cyhalothrin and its degradation products through soil.
